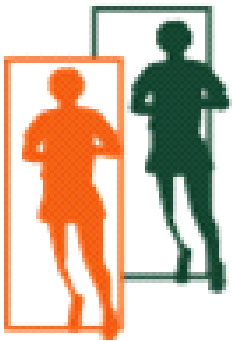

Constitution

Section I – NAME

The name of this Council is the Terry Fox Elementary Parent Advisory Council.

The Council will operate as a non-profit organization with no personal financial benefit accruing to members.

The business of the Council will be unbiased in respect of race, religion, gender, politics, sexual orientation, and physical or mental ability.

Section II – PURPOSES OF THE COUNCIL

The purposes of the Council will be:

- To promote the education and welfare of students in the school
- To encourage parent involvement in the school, and to support programs that promote parent involvement
- To advise the school board, principal, and staff on any matter relating to the school, other than matters assigned to the school planning council
- To promote the interests of public education and, in particular, the interests of Terry Fox Elementary
- To provide leadership in the school community
- To contribute to a sense of community within the school and between the school, home, and neighbourhood
- To provide parent education and professional development, and a forum for discussion of educational issues
- To assist parents in obtaining information and communicating with the principal and staff about their child's progress or other concerns
- To assist the principal and staff in ensuring the highest safety standards are maintained in the school and neighbourhood
- To organize and support activities for students and parents
- To provide financial support for the goals of the Council, as determined by the membership
- To advise and participate in the activities of Abbotsford District Parent Advisory Council and the BC Confederation of Parent Advisory Councils

SECTION III – INTERPRETATION OF TERMS

“community organizations” means groups that demonstrate an interest in education and are not already included in the scope of the Council’s constitution and bylaws

“district” means School District No. 34

“DPAC” or “district parent advisory council” means the parent advisory councils organized according to the School Act and operating as a district parent advisory council in School District No. 34

“PAC” or “parent advisory council” means the parents organized according to the School Act and operating as a parent advisory council in Terry Fox Elementary

“parent” is as defined in the School Act and mean

- the guardian of the student or child,
- the person legally entitled to custody of the student or child, or
- the person who usually has the care and control of the student or child

and, for the purposes of these bylaws, means the parent or guardian of a child or children enrolled in School District No. 34

“school” means any public elementary or secondary educational institution as defined in the School Act operating within School District No. 34

Bylaws

Section I – MEMBERSHIP

Voting members

- All parents and guardians of students registered in Terry Fox Elementary are voting members of the Council.

Non-voting members

- Administrators and staff (teaching and non-teaching) of Terry Fox Elementary may be invited to become non-voting members of the Council.
- Members of the school community who are not parents of students registered in the public school system may be invited to become non-voting than voting members.
- At no time will the Council have more non-voting than voting members.

Compliance with bylaws

- Every member will uphold the constitution and comply with these bylaws.

Section II – MEETINGS OF MEMBERS

General Meetings

- General meetings will be conducted with fairness to all members.
- General meetings will be held not less than four (4) times during the school year. One (1) of those meetings will be the annual general meeting
- There shall be an Annual General Meeting (AGM) for the purposes of election of executive board held before June 30th of each year.

Conduct

- At general meetings, members will not discuss individual school personnel, students, parents, or other members of the school community.
- The Council will refrain from partisan political action or other activities that do not serve the interests of the school or the public school system.
- If procedural problems arise on an issue not covered in these bylaws, Robert's Rules of Order (current edition) shall be used to resolve the issue.

Notice of meetings

- Members will be given reasonable notice of general meetings.

Section III – PROCEEDINGS AT GENERAL MEETINGS

Quorum

- A quorum for general meetings will be 5 voting members. 2 Executive, 3 non executive
- If at any time during a general meeting a quorum ceases to be present, business then in progress must be suspended until there is a quorum present or until the meeting is adjourned or terminated.

Voting

- Except as provided elsewhere in these bylaws, all matters requiring a vote will be decided by a simple majority of the votes cast (50% plus 1).
- In the case of a tie vote, the chair does not have a second or casting vote and the motion is defeated.
- Members must vote in person on all matters. Voting by proxy will not be permitted. In the event of a virtual meeting, all attendees' screens must display their full name and cameras must be on.
- Except as provided elsewhere in these bylaws, voting is by a show of hands or, where requested by two voting members present, by secret ballot. In the event of a virtual meeting, all voting will be conducted with an online poll.
- Parents, who are also employees or elected officials of School District No. 34 or the Ministry of Education, with the exceptions of noon hour supervisors and crossing guards, must abstain from voting on all financial matters that might be deemed a conflict of interest.
- A vote will be taken to destroy the ballots after every election.

Section IV – EXECUTIVE

Role of executive

- The executive will manage the Council's affairs between general meetings.

Executive defined

- The executive will include the president, vice-president, secretary, Treasurer and such other members of the Council as the membership decides.

Eligibility

- Any voting member of the Council is eligible to serve on the executive, except employees or elected officials of School District No. 34 or the Ministry of Education. ,with the exceptions of noon hour supervisors and crossing guards, must abstain from voting on all financial matters that might be deemed a conflict of interest.
- Any voting member of the Council is eligible to serve on the executive, except members of the same household, parents and/or guardians of the same student, relatives by blood or

marriage.

- A School District No. 34 employee may sit of the PAC Executive when there is no other PAC member who is able, or willing, to take on roles of the Executive, but will abstain from voting on financial matters as it may be a conflict of interest.

Nominations

- A call for nominations will be made one (1) month before the annual general meeting.
- A nomination committee may be formed at each April general meeting or as required by the Executive.

Election of executive

- The executive will be elected at each annual general meeting.
- Elections will be conducted by the chair of the Nominations Committee.
- An election may be by acclamation.
- Executives can be elected from the slate of nominees by a simple majority of those members present. Nominations can be taken from the floor.

Term of office

- The executive will hold office for a term of one year beginning immediately following the election.
- No person may hold the same executive position for more than four (4) years.

Vacancy

- If an executive member resigns or ceases to hold office for any other reason, the remaining executive members may appoint an eligible member of the Council to fill the vacancy until the next annual general meeting.

Removal of executive

- The members may, by a majority of not less than 75% of the votes cast, remove an executive member before the expiration of his or her term of office, and may elect an eligible member to complete the term.
- Written notice specifying the intention to make a motion to remove the executive member must be given to all the members not less than fourteen (14) days before the meeting.

Remuneration of executive

- No executive member may be remunerated for serving on the executive but may be reimbursed for expenses reasonably and necessarily incurred while engaged in the Council's affairs.

Section V – EXECUTIVE MEETINGS

Meetings

- Executive meetings will be held at the call of the president. At least one meeting will be held before the Annual General Meeting.

Quorum

- A quorum for executive meetings will be a majority (50% plus 1) of the members of the executive.

Notice

- Executive members will be given reasonable notice of executive meetings.

Voting

- All matters requiring a vote at executive meetings will be decided by a simple majority of the votes cast (50% plus 1).
- In the case of a tie vote, the chair does not have a second or casting vote and the motion is defeated.

Section VI – DISTRICT PARENT ADVISORY COUNCIL, AND EXTERNAL COMMITTEE REPRESENTATIVES

District Parent Advisory Council representative

- One representative to the Abbotsford District Parent Advisory Council may be elected annually from among the voting members who are not employees or elected officials of School District No. 34 or the Ministry of Education.

Election of DPAC representatives

- The election of representatives to DPAC must be by secret ballot.

Term of office

- -DPAC representatives will hold office for a term of one year.

Vacancy

- If DPAC representative resigns or ceases to hold office for any other reason, the membership may elect an eligible member of the Council to fill the vacancy for the remainder of the term. Such election must be by secret ballot.

External committees

- The membership or executive may elect or appoint a member who is not an employee or elected official of School District No. 34 or the Ministry of Education to represent the Council

on an external committee or to an external organization.

- The representative will report to the membership or executive as required.

Section VII – CONDUCT OF EXECUTIVE AND REPRESENTATIVES

Code of ethics

- On election or appointment, every executive member or representative must sign and agree to abide by a code of ethics acceptable to the membership.

Representing the Council

- Every executive member and representative must act solely in the interests of the parent membership of the Council.

Privilege

- Any information received in confidence by an executive member or representative from school personnel, a student, parent, or other member of the school community is privileged and must not be divulged without permission of the person giving the information.

Disclosure of interest

- An executive member or representative who is interested, either directly or indirectly, in a proposed contract or transaction with the Council must disclose fully and promptly the nature and extend of his or her interest to the membership and executive.
- Such an executive member or representative must avoid using his or her position on the Council for personal gain.

Section VIII – DUTIES OF EXECUTIVE AND REPRESENTATIVES

- **The President will**
 - speak on behalf of the Council
 - consult with Council members
 - preside at membership and executive meetings
 - ensure that an agenda is prepared
 - appoint committees where authorized by the membership or executive
 - ensure that the Council is represented in school and district activities
 - ensure that Council activities are aimed at achieving the purposes set out in the constitution
 - be a signing officer
 - submit an annual report

- **The Vice-President will**
 - support the president
 - assume the duties of the president in the president's absence or upon request
 - assist the president in the performance of his or her duties
 - accept extra duties as required
 - be a signing officer
 - submit an annual report

- **The Secretary will**
 - ensure that members are notified of meetings
 - record and file minutes of all meetings
 - keep an accurate copy of the constitution and bylaws, and make copies available to members upon request
 - prepare and maintain other documentation as requested by the membership or executive
 - issue and receive correspondence on behalf of the Council
 - ensure safekeeping of all records of the Council

- may be a signing officer
- Submit an annual report

- **The Treasurer will**
 - be a signing officer
 - ensure all funds of the Council are properly accounted for
 - disburse funds as authorized by the membership or executive
 - ensure that proper financial records and books of account are maintained
 - report on all receipts and disbursements at general and executive meetings
 - make financial records and books of account available to members upon request
 - deposit all funds collected on behalf of the Council in account at a recognized financial institution approved by the PAC;
 - have the financial records and books of account ready for inspection or audit annually
 - with the assistance of the executive, draft an annual budget
 - ensure that another signing officer has access to the financial records and books of account in the treasurer's absence
 - apply for the year Gaming Grant and file yearly summary report.
 - submit an annual financial statement at the annual general meeting

- **The Hot Lunch Representative will**
 - coordinate the monthly hot lunch days
 - arranges for menus to be supplied to students
 - collects monies and tabulate orders prior to hot lunch day
 - purchases all necessary ingredients to fill orders from student menu requests for food days
 - arranges to have the necessary volunteers to assist with the hot lunch day
 - prepares annual schedule for potential hot lunch dates, which is to be presented at the first general meeting of the school year

- **The Fundraising representative will**
 - coordinate the fundraising activities

- report back to general meetings
 - appoint volunteers to assist in the operation of fundraising activities
 - assists the treasurer in the collection of fundraising money and detailed reporting of receipts and expenditures
- **The DPAC representative will**
 - attend all meetings of the Abbotsford District Parent Advisory Council and represent, speak, and vote on behalf of the Council
 - maintain current registration of the Council
 - report regularly to the membership and executive on all matters relating to the DPAC
 - seek and give input to the DPAC on behalf of the Council
 - receive, circulate, and post DPAC newsletters, brochures, and announcements
 - receive and act on all other communications from the DPAC
 - liaise with other parents and DPAC representatives
 - submit an annual report
 - **The immediate Past President(s) will:**
 - help smooth the transition between Presidents;
 - advise and support the membership and executive;
 - provide information about resources, contacts and other information essential to the Council;
 - act as a consultant for the President(s); and
 - chair the nominating committee.

Section IX – COMMITTEES

- The membership and executive may appoint committees to further the Council's purposes and carry on its affairs.
- The terms of reference of each committee will be specified by the membership or executive at the time the committee is established, or by the committee at its first meeting, as the membership or executive decide.
- Committees will report to the membership and executive as required.
- A nominating Committee will be appointed annually before the annual general meeting.

Section X – FINANCIAL MATTERS

Financial year

- The financial year of the Council will be September 1st to August 31st

Power to raise money

- The Council may raise and spend money to further its purposes.

Bank accounts

- All funds of the Council must be kept on deposit in the name of the Council in a bank or financial institution registered under the Bank Act.

Signing authority

- The executive will name at least three signing officers for banking and legal documents. Two signatures will be required on all of these documents.

Annual budget

- The executive will prepare a budget and present it to the membership for approval for approval before the end of November each year.

Non-budgeted expenditures

- The executive will present all proposed expenditures over \$100 beyond the current budget for approval at the next general meeting.
- The executive will present all proposed expenditures beyond the current budget for approval at the next general meeting.

Treasurer's report

- A treasurer's report will be presented at each general meeting.

Auditor

- Members at a general meeting may appoint an auditor.

Section XI – CONSTITUTION AND BYLAW AMENDMENTS

- The members may, by a majority of not less than 75% of the votes cast, amend the Council's constitution and bylaws.
- Written notice specifying the proposed amendments must be given to the members not less than fourteen (14) days before the meeting.
- Where the proposed amendments exceed one page, they need not be given to every member, but must be posted in a conspicuous place in the school or made accessible to all

members.

Section XII – PROPERTY IN DOCUMENTS

- All documents, records, minutes, correspondence, or other papers kept by a member, executive member, representative, or committee member in connection with the Council shall be deemed to be property of the Council and shall be turned over to the president when the member, executive member, representative, or committee member ceases to perform the task to which the papers relate.

Section XIII – DISSOLUTION

- In the event of winding up or dissolution of the Council, and after payment of all debts and costs of winding up or dissolution, the assts and remaining funds of the Council shall be distributed to another parent advisory council or councils in School District No. 34 having purposes similar to those of the Council, as the members of the Council may determine at the time of winding up or dissolution.
- In the event of winding up or dissolution, all records of the Council shall be given to the principal of Terry Fox Elementary.
